**[2]Refund of an Exchange Order** : An Exchange Order can be refunded only at the place where the Order issued and must be within one year after the date of issue. (A handling charge and a communication fee, set in the regulations of each issuing office, will be deducted.)

**[3]Refund of ALL JR WEST PASS (After exchange to physical tickets)** : Those passes can be refunded only within the valid period and before you use the ticket for the first time at any stations. (The handling fee may be varied between different passes, please check with stations staff) No refund can be made for any reason after you use the tickets or after the valid period.
